UNIT IS BACK IN AUTO AND BREAKER IS CLOSED. THE DOORS AND GATE ARE ON AND SHUT. THIS UNIT WAS IN AN ALARM FOR BOTH THE FUEL LEVEL SENSOR AND COOLANT LEVEL SENSOR. THE COOLANT SENSORS RED WIRE IS BROKEN OFF AT THE SENSOR AND THE FUEL LEVEL SENSOR IS STUCK CLOSED.
