

APA Salaries increase—Shane Porter & Jack Compton

- Assistant Prosecuting Attorney Shane Porter will go to \$72,308./yr.
 Assistant Prosecuting Attorney Jack Compton will go to \$66,226./yr.
- These are based on Public Defender salaries and that of other APA's around the state. We are trying to retain our employees.
- The minimum for an APA is \$54,062 and the max is \$78,390. Jack's rate is at the midpoint and Shane's is above the midpoint due to his experience.
- The state public defender's office starts lawyers at \$60,000. They are a major competitor when we hire new attorneys.
