REQUEST TO UPGRADE HEAT & AIR MORGUE/WEBER RD. purchase will run in the Daily Journal and after a 10-day period the contract can be let on December 27, 2021. Commissioner Buckley seconded the motion. All were in favor and the motion passed. The County Clerk's office will run the notice of proposed purchase.

Program Director, Sherri Hampton, came before the Commission to discuss entering into a new agreement with Presbyterian Children's Home. The original 2019 contract will be terminated, and the new contract will commence on 01/01/2022, and extend through 05/31/2024. Commissioner Buckley made a motion to enter into professional service agreement with Presbyterian Children's Home and Services. Commissioner Kater seconded the motion. All were in favor and the motion passed.

Maintenance Supervisor, Brian Briley, came before the Commission to request upgrading the current air conditioning at the Courthouse. The system is old and has already had to have repairs when two compressors went out and was very costly. Mr. Briley is wanting to use Omnia Partners for the turnkey installation of Circuit Court split system replacement at a cost of \$74,985.00. Omnia is a state contract provider. Commissioner Buckley made a motion to use Omnia Partners for the air conditioning replacement. Commissioner Kater seconded the motion. All were in favor and the motion passed.

Maintenance Supervisor, Brian Briley, came before the Commission to request upgrading the current heat and air conditioning at the Morgue, Weber Road Facility. The current system does not extend into the new office space that is being constructed. Mr. Briley is wanting to use Briley Heating and Cooling for the scope of work to be done at the County Morgue. There is a verbal agreement with Briley Heating and Cooling for a cost of \$11,800.00. Commissioner Kater made a motion to use Briley Heating and Cooling. Commissioner Buckley seconded the motion. All were in favor and the motion passed. An Emergency Purchase letter will need to be drafted by the Commission for this purchase.

Commissioner Buckley made a motion to use Rapid Finance, Court Funds Program for prepaid cards for Jurors. Commissioner Kater seconded the motion. All were in favor and the motion passed.
