# Mileage Reimbursement increase

## Commission

We cannot exceed the IRS amount (currently at \$.585/mile) and must stay at least \$.03 per mile below them. Their rate is scheduled to go to \$.625 on July 2, 2022.

We currently reimburse at the rate of \$.47/ mile.

## Suggestion from Harold:

Adopt a reimbursement rate of \$.50/mile effective June 21, 2022. This rate is effective for any reimbursement form submitted after June 21, 2022 no matter what date the miles were driven.

# Approve contract with MO. Dept of Corrections (ERDCC)—R & B

- We will start using **prison detainees** to pick up trash along our County roadways. This will probably become a year-round program. **We will use a prison-provided lunch for each person.**

**Our costs:** provide a (very used) van with trailer for transportation--equipped with a porta-potty.

- Provide one trained R&B employee to drive and supervise.
- We will pay each detainee \$7.50 per DAY for the service.
- We will provide trash bags, gloves and safety-colored vests.
- Other clothing and shoes, etc. will be provided by Prison.

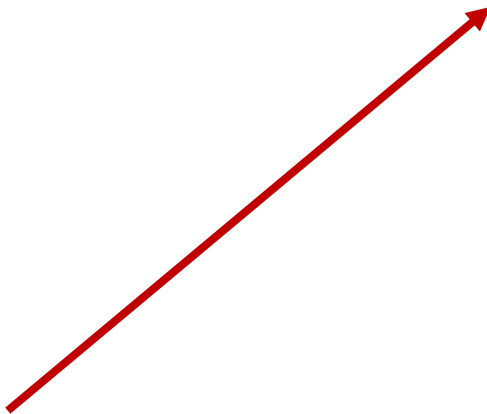
