GENERAL BUSINESS:

MO EXTENSION REPORT

Kendra Graham presented the Commission with the quarterly report for the Missouri Extension office. Mrs. Graham informed about the various programs, activities, and upcoming events the Extension office is involved in.

BID OPENING CAMERA'S SHERIFF DEPT. Bids were opened for cameras at the Sheriff's Department. There were three bids received, Williams Alarm LLC, Roberts Alarm Systems, and Turn-Key Security Solutions. These bids will be taken under advisement.

APPROVE PURCHASE RD & BRIDGE

Hwy Administrator, John Gross, came before the TWO NEW PICK-UP TRUCKS/ Commission requesting permission to purchase two new pick-up trucks for Road & Bridge from Auffenberg Chevrolet. The trucks were approved to be purchased last year but there was no delivery date set for them. Mr. Gross wishes to purchase the trucks off the lot, but the cost will be \$46,278.70 for one truck and \$45,585.53 for the other truck.

Purchasing off the lot the discount for Fleet vehicles is not available but the cost is cheaper than originally quoted. Commissioner Buckley made a motion to approve the purchase of the trucks paying \$46,278.70 for one and \$45,585.53 for the other pickup truck. Commissioner Kater seconded the motion. All were in favor and the motion passed.

REQUEST SCANNING PROJECT/VITAL RECORDS RECORDER OF DEEDS

Jay Graf, Recorder of Deeds, would like permission to bid the scanning project for vital records. Commissioner Kater made a motion to bid scanning project. Commissioner Buckley seconded the motion. All were in favor and the motion passed.

OWL CREEK PARK GRANT/MO CONSERVATION

Commissioner Buckley made a motion to apply for the Outdoor Recreation Infrastructure Grant through MO Department of Conservation. The grant would be used to construct two (2) sets of bathrooms, drinking fountains, and electric to bathrooms. If awarded the maximum award amount is \$300,000 and would be a 25% match for the County. Commissioner Buckley seconded the motion. All were in favor and the motion passed.

OUTSTANDING ASI INVOICES

Corey Schrum, HR, is asking permission to pay \$2,400 for the ASI outstanding invoices. The original agreement was to waive the fee for employees that wanted to use the flex spending account through Colonial Insurance but is handled by ASI. The agreement was made with an employee who is no longer with Colonial insurance and upon review the amount cannot be waived. With discussion between the Commission and the Auditor it was decided to table this item until next week.
