REQUEST TO APPLY BLOCK GRANT BUMPER GUARDS SHERIFF DEPARTMENT

The maximum award amount is \$10,000 through Missouri Department of Public Safety and is a non-matching grant. If awarded the grant would be used to purchase bumper guards for the patrol vehicles. Commissioner Buckley made a motion to apply for the block grant for the bumper guards. Commissioner Kater seconded the motion. All were in favor and the motion passed.

REQUEST OPIOID FUNDS SHERIFF DEPARTMENT

LT Michael Ryan, came before the Commission to request permission to apply for \$64,000 from the Opioid Settlement Fund. LT Ryan explained that should the funds be awarded they would be used to offset the 25% cost match for the RSAT grant for the Sheriff's Department. Commissioner Buckley made a motion to allow LT Ryan to apply for funds from the Opioid Settlement Fund for the Sheriff's Department. Commissioner Kater seconded the motion. All were in favor and the motion passed.
